
## **OVERVIEW**

## QUALITY ASSURANCE

The ELT Council has established comprehensive Quality Assurance processes in pursuance of two of its key functions to:

- i. maintain and operate quality assurance systems in all aspects of English Language stays that provide for periodic rigorous audits to assure compliance with established quality standards;
- ii. foster Malta's reputation as an international learning centre of repute in all aspects of ELT stays.

#### MONITORING EXERCISE

A Schools' Visit policy is in place and all Schools are visited at least once every two years. Each visit covers both regulatory compliance matters and academic aspects. Visits this year were held between July and September 2023. An announced visit is held in all licensed ELT operations once every two years, therefore schools visited in 2022 were not visited in 2023. Schools were contacted by a Monitoring Officer to schedule a visit. The scope of the visits is to confirm legal compliance of the operator, provide an opportunity for improvement as well as to enhance the quality of the ELT Industry in Malta.



Families and Work Study Visas. The purpose of this working group was to bring together the ideas presented by the participants. Meetings took place in January, March, and April 2023. The campaign spanned three weeks, involving radio advertisements as well as promotions on *Gwida*, *MaltaToday*, and *Times of Malta*. The cost of the campaign amounted to €20,000.00 which was done in collaboration with Malta Tourism Authority.
